SPROUTING FROM THE RIVER



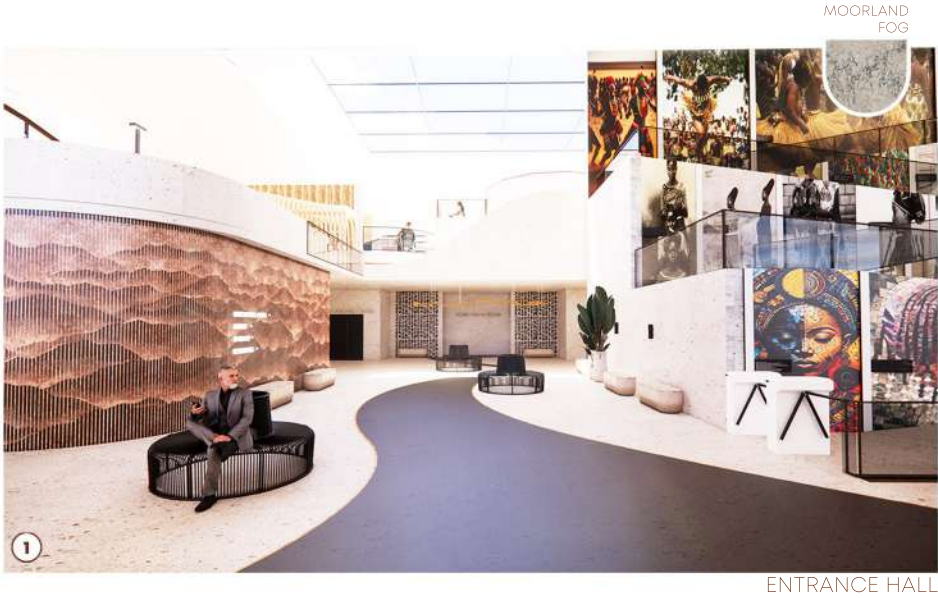

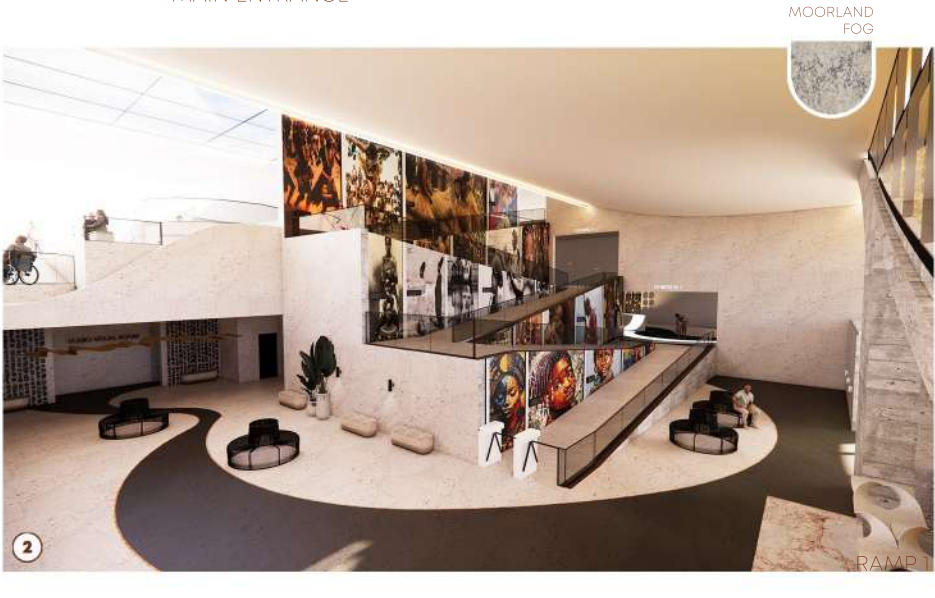

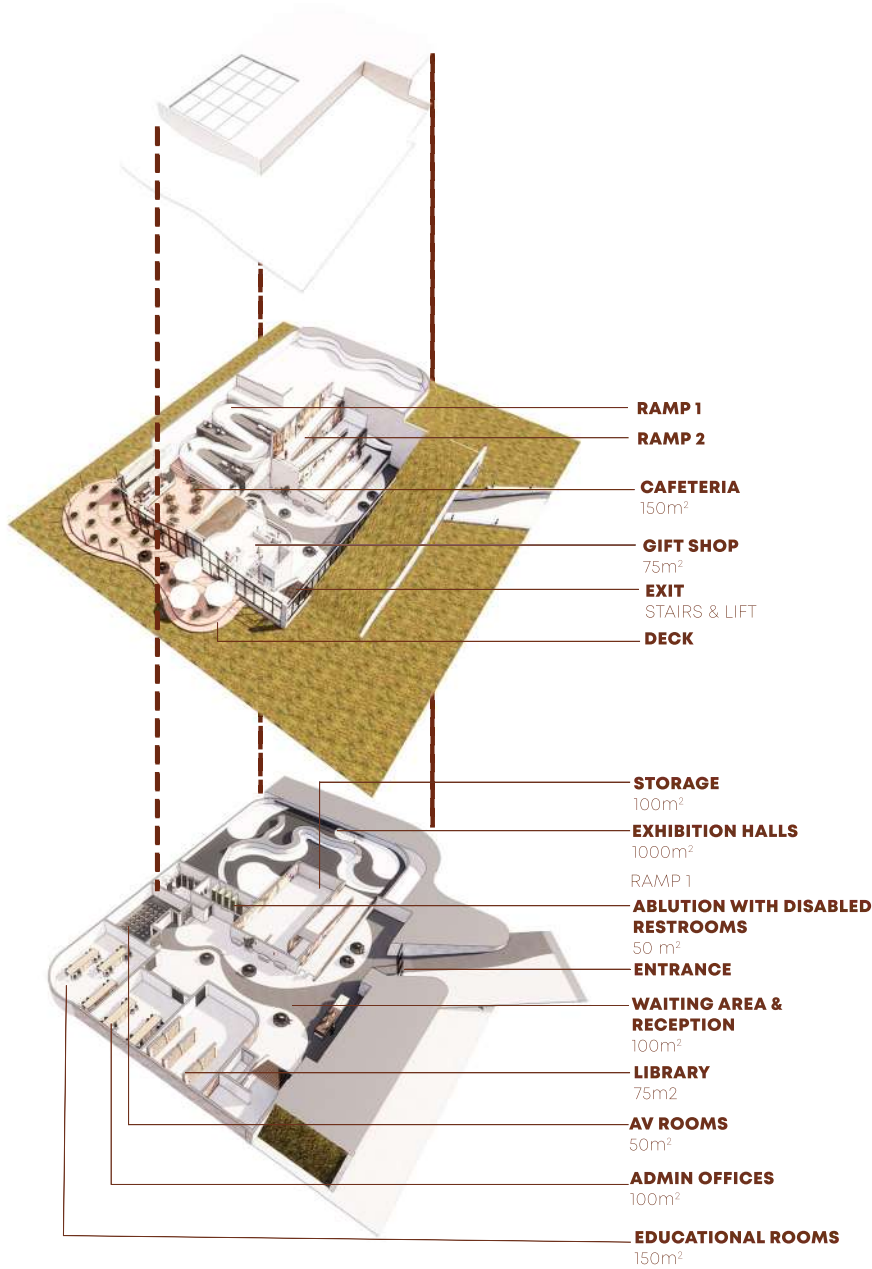

The tributaries flow throughout the building :

1.Reception The curved entrance floorpattern starting from the outside flows through the building, leading to the audio visual room ending at the black sound panels celebrating the intonation & diversity of the different languages. **2. Ramp** The ramp leads the viewer through the three exhibition halls to become one with the journey of languages by narrating the histories and development of languages over time through pictures, artworks & written scripts. **3. Exhibition 1** a curved interactive electronic counter display that symbolizes the tributaries flow. Housing information about linguistic diversity, artefacts & historical objects. A "Word of the Day" interactive learner experience where the user can swivel a block around to learn a word from another language, and a brail wall to interact with the only language that truly crosses the divide between all languages and cultures. **4. Cultural exchange room** where visiting exhibitions takes place. **5. Exhibitions exit ramp** providing the viewer with a tranquil pause space to reflect on the journey they have just completed through the exhibition halls. This space showcases rocks with writing on to symbolise the preservation & revitalisation of endangered languages. **6. Lifestyle Kauai** with an outside view. **7. Curved pathway** leading through the giftshop to exit lift and stairs.

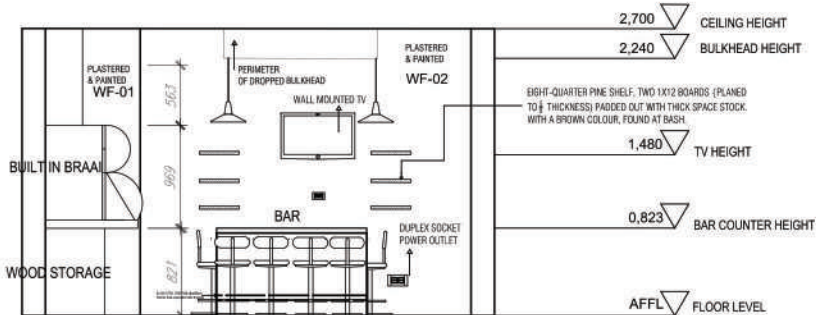


DRAINAGE PLAN AND SANITARY ALLOCATION LAYOUT

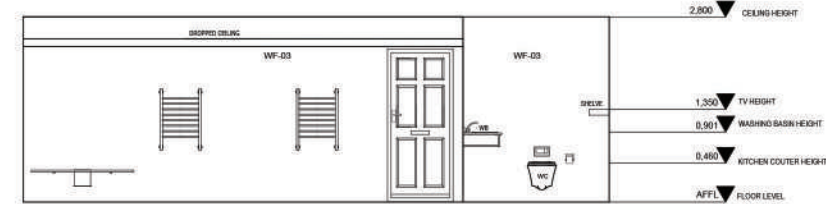
REFLECTED CEILING PLAN
